Motions carried with all Ayes unless noted. Lemley, Larsen moved to approve the consent agenda but to move #11 and #6 to the top of the agenda. CARRIED. K. Brown, S. Brown moved to approve the consent agenda (minutes, Clerk's reports and bills received). CARRIED. Water samples were read from the Community Building and Care Center, reported safe and filed.

Numerous citizens voiced concerns about being able to drive golf carts after dark. According to state code, golf carts can only be driven between sunrise and sunset and also are not to be operated on a city street that is a primary road extension through the city. No action taken on any revisions of City code.

K. Brown, Lemley moved to appoint Baton Cramer, Karleen Knock, Todd Zeman and Gordon Viers to the Planning and Zoning Commission, but to stagger the terms. CARRIED. S. Brown, K. Brown moved to appoint Mitch Swinton for a five year term on the Board of Adjustment. CARRIED. Lemley, S. Brown moved to appoint Kyra Banos and Gabe Coppinger to the Junior Division of the Cable TV Commission. CARRIED. Lemley, S. Brown moved to appoint Brad Judge and Luis Zuniga to the Adult Division of the Cable TV Commission. CARRIED.

S. Brown, Lemley moved to approve **RESOLUTION 2010-O** (APPROVING A **TERM ON THE LIBRARY ADVISORY BOARD).** CARRIED.

S. Brown, Lemley moved to approve option #2 to install carpet on the floor at the Community Building. CARRIED.

Don Werbach was present to request he be allowed to dig across Pioneer Road in order to install a field tile drain and also to tap into one of the concrete retainage boxes on W. Linn Street with a field tile. More research will be done on the request.

K. Brown, Larsen moved to allow maintenance personnel to attend the CCR meeting in Coralville this month. CARRIED. K. Brown, S. Brown moved to allow maintenance personnel to attend the IWPCA Region 6 meeting if they wish. CARRIED.

S. Brown, Larsen moved to approve to upgrade the electrical work in North Park and to include a timer for the lights. CARRIED. S. Brown, Larsen moved to approve pest control to spray the North Park big pavilion for powder post beetles. CARRIED.

Right-of-way regulations Ordinance will be updated for the May meeting. No formal action taken on 2010 budget amendments or nuisance/health complaints.

S. Brown, Coppinger moved to accept the lowest bid for chip and seal work after soliciting bids from other companies. CARRIED.
